JOB SUMMARY

Under the general direction of the Grounds/Repair Foreman, the Ground Crew Laborer installs, maintains and cares for landscaping including mowing, tree care, fertilization, aeration, herbicide spraying; installs and maintains irrigation systems including controller programming and central control systems.

ESSENTIAL JOB FUNCTIONS

- Installs landscape including trees, shrubs and lawn areas.
- Installs, upgrades, maintains and repairs irrigation systems.
- Assists in determining supply and equipment requirements.
- Operates and maintains mowing and turf-care equipment including aerators, seeders and sweepers.
- Operates and maintains district vehicles including dump trucks and tractors.
- Inspects, picks up, repairs, maintains and delivers school yard equipment including Big Toys.
- Available and assists with snow removal including driving a snow plow.
- May be assigned to supervise a crew (i.e. giving work assignments, inspecting work and instructing in work practices and procedures.) Assists in determining work assignments.
- Performs synthetic turf repair and backflow testing.
- Assists in developing of mowing assignments and schedules.
- May assist with arrangements for transportation of part-time workers to and from job sites.
- Assists in any other shop as assigned.

MINIMUM REQUIREMENTS

- High School diploma or equivalent.
- Some experience preferred.
- Driver's license.

- Ability to obtain a CDL license within four months.
- Ability to obtain a Utah State Pesticide Applicators License within six months.

KNOWLEDGE, SKILLS AND ABILITIES

- Ability to read and write and perform basic mathematical calculations, as required in reading labels, mixing hazardous materials and in maintaining ground/repair records.
- Knowledge of equipment maintenance and safety procedures.
- Knowledge of landscape and irrigation including thorough knowledge of installation and repair.
- Knowledge of playground maintenance and safety requirements.
- Practical maintenance knowledge and ability.
- Ability to read construction drawings, details and diagrams for landscape and irrigation purposes.
- Knowledge of material safety data sheets.
- Knowledge of fertilizer types and application practices.
- General knowledge of arboriculture practices and standards.
- Knowledge of snow plowing practices and ability to perform snow plowing after normal work hours.

PHYSICAL DEMANDS
