#### **JOB SUMMARY**

Under the direction of the Early Childhood Education Specialist or Head Start Education Coordinator, the Pre-Kindergarten Instructor develops and implements developmentally appropriate classroom learning experiences to enhance social and academic learning opportunities. Ensures the developmental needs of all children are addressed. Maintains a safe, organized, learning environment. Implements the program's philosophy and adheres to the Head Start Program Performance Standards.

#### **ESSENTIAL JOB FUNCTIONS**

- Provides a safe and supportive classroom environment that promotes exploration and learning.
- Plans and implements daily curricula that promotes children's social, emotional, physical, and cognitive growth; supports the program's school readiness goals.
- Evaluates each child's needs and skills, no less than three (3) times yearly, and completes a written assessment that is shared with the parents.
- Maintains a record of observations on each child, documenting social and academic progress toward individualized goal achievement.
- Works with parents to develop and implement an Individualized Education Plan for children receiving special education services.
- Adapts planned classroom learning experiences to meet the needs of all children, including children with disabilities and dual language learners.
- Model cultural and linguistic responsiveness; providing first language support whenever possible while simultaneously supporting English acquisition for dual language learners.
- Involves parents in the child's learning experience through home visits, parent-child activities, parent-teacher conferences, telephone contact, calendars, written communication, and online parent education resources.
- Creates and implements lesson plans that are individualized based on children's needs identified in assessments and observations.

- Implements learning experiences that are aligned with the Utah Pre-Kindergarten Guidelines and the Head Start Early Learning Outcomes Framework.
- Provides adequate active supervision at all times to ensure the safety and well-being
  of every child throughout the day; Keeps classroom safe and free from hazardous
  materials.
- Meet Head Start program requirements for home-visits, parent-teacher conferences, individualized education planning, and required health and safety training for children.
- Oversees teacher assistants and volunteers in the classroom; provide opportunities allowing them to build teaching skills and develop effective teacher-child interactions.
- Participates in snack and lunch with the children; modeling family-style meals and using mealtime as an opportunity to teach children self-help and social skills.
- Assists children in brushing teeth, washing hands, changing soiled or wet clothing, etc. May assist with toilet training.
- Administers first aid for minor cuts or injuries.
- Monitors children for illness or other health problems and reports signs of neglect or suspected child abuse to proper authorities.
- Make referrals to appropriate managers, mental health consultant and disabilities liaison to assure all children and families receive maximum services.
- Actively participates in all required meetings and professional development opportunities.
- Actively participate in IEP meetings for children with special needs including sharing observational assessments, anecdotal notes, and educationally relevant information.
- Coordinates monthly fire and earthquake drills.
- Maintains classroom supplies and materials based on allocated budgets.

# MINIMUM REQUIREMENTS

- Associate degree in Early Childhood Education, Child Development, or a related field accepted with a minimum of two (2) years of related experience.
- Bachelor's degree in Early Childhood Education, Child Development, or a related field preferred.
- Food handler's permit.
- Driver's license.
- First aid and CPR certification (Training provided by the program)

#### **KNOWLEDGE, SKILLS AND ABILITIES**

- Strong knowledge of early childhood education and developmentally appropriate practices.
- Understanding of special populations including children with disabilities, dual language learners, cultural diversity, and children living in poverty.
- Knowledge of basic health care for young children.
- Strong organization and leadership skills.
- Ability to work effectively with young children and adults.
- Ability to administer developmental screening tests.
- Ability to write an educational plan including follow-up and evaluation.
- Ability to use small office equipment and computers.
- Ability to manage inventory and property.
- Ability to prepare purchase orders.
