JOB SUMMARY

Under the general supervision of the teacher of the hearing impaired/deaf and in consultation with the mainstream teacher, the Educational Interpreter II uses voice/sign transliteration to communicate to the student all concepts presented in the mainstream classroom. The incumbent also interprets during assemblies, field trips and other special events, and facilitates communication between the deaf student and the teacher or other students.

ESSENTIAL JOB FUNCTIONS

- Signs lectures given by teachers, discussions, public address and school announcements, videos and movies, assemblies and programs.
- Voices/signs the deaf student's conversations with the teacher or other students.
- Consults with the mainstream teacher and teacher of the deaf concerning upcoming classroom material so the appropriate sign vocabulary will be available to the student, interpreter and teachers.
- Sets up the closed caption decoder for videos and movies.
- May tutor the deaf student by explaining new vocabulary, agreeing on signs, reexplaining assignments, and providing any other tutor-related support for the student.
- Teaches sign language, if requested, within the deaf student's classroom.
- Finds qualified classmates to take notes as needed and provides NCR paper to the note taker.
- Ensures that the deaf student has preferential seating in order to be able to see the teacher, blackboard and interpreter.
