JOB SUMMARY

Under the general supervision of the maintenance coordinator over outdoor environment, the irrigation/grounds foreman supervises the installation, maintenance and repair of District landscape irrigation systems. This includes responsibility for all sprinkling systems, including automatic valves, piping, heads, time clocks, and backflow devices. Oversees all aspects of grounds related duties.

ESSENTIAL JOB FUNCTIONS

- Reviews and assists in prioritizing job sheets and maintenance work requests. Assigns work schedules and daily tasks to department employees.
- Inspects job site work, assists crews with problems and supervises projects to completion.
- Prepares plans for special projects (e.g., sprinkling systems).
- Orders material, computing quantities needed and scheduling deliveries to job sites.
- Designs some of the District sprinkler systems and purchases required materials.
 Prepares specifications, contacts vendors, obtains bids, etc.
- Orders replacement parts for sprinkler systems.
- Assists with installation, updates, maintains and repairs sprinkler systems.
- Coordinates scheduling of sprinkler work with other departments.
- Communicates project requirements with other maintenance departments.
- Coordinates and assists with inspections and resolution of problems with Health Department. Maintains related records, discusses concerns and prepares required reports.
- Meets with principals to discuss maintenance procedures and requirements.
- Provides basic skill and safety training to crews.
